

**RAIN FLOW TOTAL GUTTER PROTECTION  
20 YEAR LIMITED WARRANTY**

Rain Flow USA, Inc. hereby warrants that Rain Flow Total Gutter Protection (hereinafter called Rain Flow) is free from defects in material and workmanship when it was shipped from the factory. Rain Flow, when properly installed, will keep gutters free-flowing for a period of 20 years from date of installation.

For this warranty to be in effect, Rain Flow must be purchased directly from Rain Flow USA, Inc. or from an authorized re-seller of Rain Flow USA, Inc. In addition, all gutters must be thoroughly cleaned and all connected downspouts and any connected underground drains must be clear and free of debris and/or obstruction. Also, gutters must be properly sloped according to local codes in effect where Rain Flow is installed. Because conditions vary on every application such as, but not limited to, roof pitch, roof valleys, and gutter splash guards, it is understood that occasional maintenance may be required by the homeowner or building owner/manager. This warranty is void if Rain Flow is not installed according to Rain Flow USA, Inc. installation provisions and instructions.

This warranty requires that the warranty registration form below be completed and signed by the initial purchaser and returned to Rain Flow USA, Inc. within 30 days following the installation of Rain Flow.

Should Rain Flow have material or workmanship defects, or fail to keep gutters free flowing during the period of this warranty, and all aspects of installation are correct, Rain Flow USA, Inc. will replace the defective Rain Flow upon receipt of such defective product returned to the company in adequate and reasonable packaging. Proof of purchase and a detailed letter describing the failed condition are a requirement of fulfillment of this warranty. Removal and re-installation costs and product return shipping costs are not covered by this warranty.

Rain Flow USA, Inc.'s warranty is limited to replacement of defective material, and Rain Flow USA, Inc. specifically excludes from this limited warranty any liability for structural or cosmetic damage to the home or building on which Rain Flow is installed, including but not limited to direct or indirect, consequential or other damages resulting from the use of Rain Flow. Rain Flow USA, Inc. is not liable for any other oral or written warranty such as those that may be given by Dealers, Contractors, Installers, or Distributors of this product. Further, Rain Flow USA, Inc. shall not be liable for damages caused by misuse, abuse, improper installation, or acts of God.
